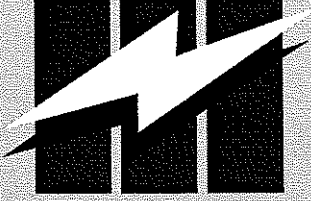

Bidders shall furnish an original Bid Security along with their bids in the amount of **USD 1.0 Million**. The Bid Security shall be issued by a Commercial Bank operating in Mauritius and shall remain valid up to 30 days after the Bid Validity date, i.e. **up to 12 March 2026**.

A pre-bid meeting is scheduled for **Wednesday 16 July 2025 at 10.30 hours (Mauritian Time)** at the Centre de Formation et de Perfectionnement Professionel (CFPP), Bois Marchand Road, Terre Rouge.

Bids will be opened on **Friday 15 August 2025 as from 13.45 hours (Mauritian Time)** in the **Conference Room, Central Electricity Board Office, 3<sup>rd</sup> Floor, New Building, Royal Road, Curepipe, Republic of Mauritius** in the presence of bidders or their representatives who choose to attend.
