Bidding will be conducted through **International Competitive Bidding procedure** (Eligible local bidders may also submit their bids as appropriate).

Country of origin/manufacturer of items shall be of USA, Europe South Africa and Japan.

In case of USD transfer, proof of remittance of the money transfer shall be submitted to the CPSTL on or before Wednesday, 03rd May 2023.

Bidders are requested to inspect the bidding document prior to purchase and once it is purchased, bidding document fee is not refundable for any reason whatsoever

Bids will be closed at 1400 hrs. Sri Lanka local time (GMT+5:30) on Thursday, 04<sup>th</sup> May 2023 and will be opened immediately thereafter at the office of Manager (Procurement) in the presence of the authorized representatives of the bidders who chose to attend. Only one authorized member of respective bidder is allowed to participate /witness the tender opening procedure.
